The Peritoneal Dialysis Unit is responsible for training and maintaining patients in doing their own peritoneal dialysis at home. The Peritoneal Dialysis Unit consists of a strong internal multidisciplinary team and has a close relationship with the Community Care Access Center (CCAC). The team focuses on continually improving patient outcomes and promoting self-management of their chronic disease.

- Demonstrated ability to function as an independent primary nurse of a large group of outpatients, with excellent independent nursing assessment skills
- Previous experience with teaching staff new skills individually or in groups
- Demonstrated ability to plan, implement and evaluate patient/staff education programs and materials
- Demonstrated effective communication, critical thinking, team-building and interpersonal skills
- Demonstrated ability to prioritize and organize workload
- Evidence of commitment to self-directed learning
- Evidence of motivation to be an enthusiastic and effective member of an interdisciplinary team
