2.1	Presentation	Dr. Louise Moist, Nephrologist, presented research on Educational support around dialysis modality decision-making in patients with Chronic Kidney Disease (CKD): a qualitative study. This research was done in conjunction with past PFAC member Mike Smith who was unable to attend. -Purpose of the study was to understand the dialysis modality decision-making process through exploration of the pre-dialysis patient experience to better inform the educational process.	2018 09 11 minutes attachment Moist_Sm

		 -12 patients were interviewed, and common themes surrounding dialysis modality education and support were examined -study results showed: there was/is no one method of patient education around dialysis modality decision making that is the best and that education needs to be individually tailored to each patients' needs and preferences at the time that they are learning about dialysis modalities Patients' modality decisions are influenced by their preferences and values, education delivered, and support systems available Education can be improved through the standardization of a CKD curriculum and the establishment of a patient-clinician partnership Must consider each patient's unique situation to identify and overcome educational challenges and achieve informed, shared decision-making

3.4	Other Committee Reports: Parkwood Project	-Betty still involved ad-hoc as needed -currently only 2 LTC veterans care patients at Parkwood, which would usually warrant that Parkwood would temporarily close and send patients to VH (under 3 patients they would close), however in the interest of continuity for the 2 LTC patients management has opted to leave it open -the beginning phases of the evaluation for the Parkwood proof of concept are underway	and applications if needed
